What is a GK home?

A GK home is a modest 200-250 sq. ft. home, with the following features:

- Concrete flooring, paved
- Galvanized iron roofing
- Kitchen
- 1 Enclosed room
- Painted with bright colors
- 1 Toilet
- Access to potable water
- Landscaped gardens

How can a donor(s) participate in the building of homes in GK projects ?

By donating the cost of one whole unit (\$2,800) or a share in one unit by filling up the pledge form and the method of payment, one time or installment and by cash/check or credit card or preauthorized payment, signing the form and mailing it to the Ancop Canada Area office nearest to their address.

A group of donors can donate 10 to 30 houses by executing a Memorandum of Agreement (MOA) with AICI.

Families or households can group-share in the cost of one unit, i.e. 7 couples contribute \$50/month each for 8 months.

Fundraising events like the GK Walk can help solicitors raise funds

Joining the GK Walk can raise funds for your village. Tax receipted funds raised will be directed to their group's village.

What is the cost of a GK home?

A GK home costs \$2,800 which covers the basic material cost of a 200-250 sq. ft. home. Labor cost comes from sweat equity: beneficiary and volunteer labor. Site development costs (deep wells, pavements, sewer systems) and peripheral costs (multi-purpose halls, playgrounds) come on top of the \$2,800 CDN (current cost as of June 1, 2009).

Cost of the GK home is subject to change without prior notice due to factors beyond the control of AICI and GK.

Factors that affect the price are the oil prices affecting cost of construction materials and currency exchange.

What are the criteria for GK area selection?

- Poor and marginalized area in a locality.
- Land issues resolved.
- Existence of a dedicated GK caretaker team to oversee implementation of the GK project, mobilize volunteer resources, provide feedback to donors and to ensure that value formation program is carried out.
- Willingness of the locals to set up a Kapitbahayan association.

What are the criteria for GK beneficiary selection?

- Poorest of the poor (A survey is conducted to determine income, source of livelihood, family size)
- Willingness to give sweat equity payback
- Willingness to abide by the rules, and be active members, of the Kapitbahayan.
- Willingness to go through the values formation program.
